Item No. Do not enter anything in the 'Date received' space. It is reserved for office use.

[1] Enter the **full name** of the Volkssport Club, Volkssport Tour or Travel Company / Organization.

[2] State the Club **CVF Membership Number**; e.g. CVF 107 [For new clubs: Leave space blank]

[3] Show **type of event**: e.g. YRE, Guided Walk, Annual Volksmarch, Seasonal, Short Seasonal, etc.
